Dear Director Haggard:

During the 2006 General Assembly session, changes were made to T.C.A. § 49-7-2202 and 49-7-2203. Your institution was previously informed of these changes by letter on June 29, 2006.

The change in the law requires that any college/institution that must submit criminal statistics to the Secretary of the U.S. Department of Education under 20 U.S.C.A. 1070 et. seq. will be required to report to TIBRS. Your college/institution falls under the Higher Education Commission category of Authorized Postsecondary Institutions that are required to report to the U.S. Department of Education.
